

**Visa Entertainment New Zealand /The Edge/ Disneys Pirates Of The Caribbean:
On Stranger Tides
Terms and Conditions**

Information on how to enter the Promotion forms part of these Terms and Conditions. Entries not made in accordance with these Terms and Conditions will be disqualified.

Section 1: Promotion

1. Promotion: Enter the competition by visiting The Edge website and answering five questions to enter the competition before [Thursday 12 May 2011] to go in the draw for a chance to win a Visa Entertainment prize package.

Section 2: Eligibility

Section 3: Entry to the Promotion

7. Eligible entrants who enter between the relevant dates will automatically receive one (1) entry to the Promotion.

Section 4: Draw

9. Draw:
